

## DATA PROTECTION DECLARATION

The following data privacy statement is to inform you about the nature, extent, purpose, duration and legal basis of the processing of personal data.

### 1. DATA COLLECTION ON OUR WEBSITE / GENERAL INFORMATION

The operators of these pages take the protection of your personal data very seriously. We treat your personal data, i.e. all personal data that you can be personally identified with, in confidence and in accordance with the legal data protection regulations and this data protection declaration.

When you use this website, various personal data will be collected. Personal information is information that can personally identify you. This privacy policy explains what information we collect and what we use it for. It also explains how and for which purposes this happens.

The data processing on this website is carried out by the website operator, whose contact data can be found in the imprint of this website.

On the one hand, your data will be collected through your communicating this data to us, for example data which you send us yourself via e-mail through a corresponding link.

Other data is collected automatically through our IT systems when visiting the website. Above all, these are technical data (for example internet browser, operating system or time of the page view). The collection of this data occurs automatically as soon as you enter our website.

Part of the data is collected to ensure error-free use of the website. Other data may be used to analyse the user habits.

At any time you have the right to receive free information about the origin, recipient and purpose of your stored personal data. You also have the right to request the correction, blocking or deletion of this data. For this purpose and for further questions about data protection, you can contact us at any time at the address given in the imprint. Furthermore, you have a right of appeal to the competent supervisory authority (see below).

Your surfing behaviour will not be statistically evaluated when you visit our website.

Our website does not use so-called cookies.

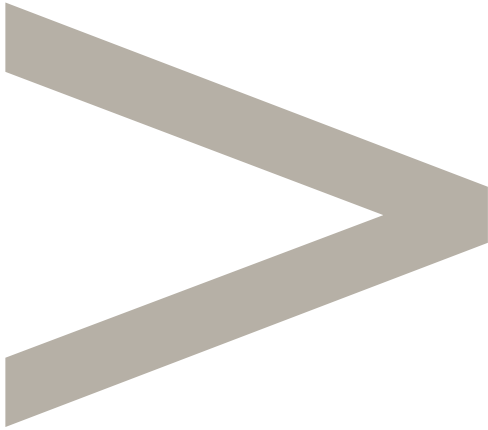
The website provider automatically collects and stores information in so-called server log files, which your browser automatically transmits to us. This includes:

- browser type and browser version
- used operating system
- referrer URL
- host name of the accessing computer
- time of the server request
- IP address

This data will not be merged with data from other sources.

Basis for data processing is article 6 paragraph 1 lit. b DSGVO, which allows the processing of data to fulfill a contract or pre-contractual measures.

We emphasise that data transmission over the internet (for example, when communicating via e-mail) may have security loopholes. Complete protection of the data from access by third parties is not possible.



## 2. RIGHTS OF USERS AND PARTIES CONCERNED

Many data processing operations are only possible with your explicit approval. You can revoke an existing approval at any time. An informal message by e-mail to us is sufficient for this. The legality of the data processing carried out until the revocation remains unaffected by the revocation.

In case of violations of data protection law, the person concerned has the right of appeal to the competent supervisory authority. The competent supervisory authority for data protection issues is the data protection commissioners of the federal state in which our company is based ([https://www.bfdi.bund.de/DE/Infothek/Anschriften\\_Links/anschriften\\_links-node.html](https://www.bfdi.bund.de/DE/Infothek/Anschriften_Links/anschriften_links-node.html)).

You have the right to have the data that we process based on your approval or in fulfillment of a contract, to yourself or to a third party, be made available in a common, machine-readable format. If you require the direct transfer of data to another person responsible, this will only be done as far as it is technically feasible.

Within the scope of legal regulations, you have the right to free information about your stored personal data, their origin and recipient and the purpose of the data processing and, if necessary, a right to rectification, blocking or deletion of this data.
